CALL FOR APPLICATIONS

The Gozo Action Group Foundation (GAGF) announces that it is launching the below calls for applications under the EU LEADER programme 2014 – 2020. These actions fall under part of the Local Development Strategy for Gozo and Comino.

- **Measure 2 – GAG2 - “A Truly Holistic Gozitan Gastronomy” (Second Call)**

This measure provides for the creation of projects involving Gozitan agriculture and food produced and/or consumed in Gozo in a manner which sustains the appreciation and evolution of the Gozitan culinary tradition, generates better economic value added in Gozitan agriculture and food production, and which benefits the health of consumers. The call has been allocated a total budget of **€100,000 of public funds**. Applicants must include partnerships between operators in agriculture, agri-producers and/or catering, and/or representative bodies thereof. Participation from NGOs (mainly related to culinary arts/research, tourism, consumers’ interest, sustainable agriculture, etc.), Local Councils and educational/research institutions with a direct interest in Gozitan culinary traditions would also be desirable.

- **Measure 3 – GAG 3 – ‘Gozo Attractions and Innovative Events for all Seasons’ (Second Call)**

This measure will provide opportunities for investment in infrastructure and innovative events which will in a complementary manner strengthen Gozo’s tourism offering so as to enhance performance across all seasons, in a sustainable manner. The call has been allocated a total budget of **€363,377.94 of public funds**. Applicants must include partnerships between business operators with a direct interest in tourism and/or representatives’ bodies thereof, Local Councils and/or public governance entities with a direct interest in the Gozo region, and NGOs.

The above calls open on Monday, the 27th of June 2022 and close on Thursday, 28th of July 2022 at noon. Applications must be submitted by hand to the offices of GAGF at 23, Triq G.P.F. Agius De Soldanis, Victoria, Gozo, VCT 1032.
